# WHAT IS THE LIONS OF MICHIGAN FOUNDATION?

- The Lions of Michigan Foundation is a public charity that was created in 1984 to help Michigan Lions Clubs provide community services. The Lions of Michigan Foundation works in partnership with its member Lions Clubs and other organizations to address serious human needs and improve quality of life.
- The Lions of Michigan Foundation helps financially struggling Michigan residents whose options for affordable medical treatment are limited. Primarily, foundation provides vision, hearing and emergency services aimed at helping Michigan residents maintain their independence, excel in school and prosper in life.
- The Lions of Michigan Foundation's slogan is "Partners in Service" which both describes its close relationship with Michigan Lions Clubs and Lions auxiliaries and its philosophy on making a difference in the lives of disadvantaged people in Michigan. It is the foundation's belief that by combining resources and working together with other charities, businesses and foundations, it can better address the issues that face the state of Michigan and confidently confront the challenges that lie ahead.
- The Lions of Michigan Foundation's close working relationship with its 500 Michigan Lions Clubs and auxiliaries enables it to readily identify, select, and effectively provide services for individuals and their families who need help to deal with their medical problems or quality of life issues.

#### HOW CAN YOU HELP THE LIONS OF MICHIGAN FOUNDATION AND PEOPLE IN MICHIGAN?

- Like most charities and community service organizations, the Lions of Michigan Foundation receives the bulk of its annual revenue through donations from individuals and businesses. There are many ways to support the Lions of Michigan Foundation, including making a donation through one of the Lions of Michigan Foundation's websites: www.lmsf.net or www.lhcmi.org; making a donation when filing your Michigan Income Tax Return; or remembering the Lions of Michigan Foundation when completing your estate planning.
- The Lions of Michigan Foundation is 1 of only 9 Michigan charities that can receive donations through annual Michigan Income Tax Return filings. Michigan tax payers can donate to the Lions of Michigan Foundation by completing Form 4642 (Michigan Voluntary Contribution Schedule), selecting the Lions of Michigan Foundation Fund and the donation amount, and attaching Form 4642 to their Michigan Income Tax Return.
- No matter what your situation, you owe it to yourself and your family to plan for the future.
